WHEREAS, bids for the plasma cutting table have been solicited, made, opened and reviewed pursuant to applicable Nebraska State Statutes; and,

WHEREAS, based on those proceedings, this Board has duly deliberated and considered the bids received; and,



WHEREAS, it is in the best interest of Sarpy County to reject bids for said project.

NOW, THEREFORE, BE IT RESOLVED pursuant to Neb. Rev. Stat. §23-108 and Neb. Rev. Stat. §39-810 that the Sarpy County Board of Commissioners hereby finds and determines that the bids for the purpose set forth above be and hereby are, rejected. The Clerk of the County is hereby directed to notify the bidder of this Board's action, to return the bid bonds posted herein, if necessary, and to take such other steps as may be necessary to effectuate the rejection of the offered bids.

The above Resolution was approved by a vote of the Sarpy County Board of Commissioners at a public meeting duly held in accordance with applicable law on the 24th day of January, 2017.

Re: Plasma Cutting Table

On November 23, 2016, 3 bids were opened for the Plasma Cutting Table for Fleet Services. After reviewing the bids, it is recommended the bids be rejected. Fleet Services had the plasma cutting table in their budget as \$31,715 being financed over twenty four months. The lowest bid for the plasma cutting table came in at \$49,141.24. After reviewing the needs of the Fleet Services Department, it was determined that the need for an air compressor outweighs the need for a plasma table. Therefore, Fleet Services intends to use the funds for the plasma table for a new air compressor. The estimated costs for the air compressor is \$8,000 - \$9,000.
